- With 21 votes reported but only 20 valid votes , the results are as follows:
 - The membership committee's proposal received 11 yes votes & 9 no votes.
 - Jon Karner's proposal received 7 yes votes & 13 no votes.
 - o 1 vote was null & void as it was 2 yes votes.
 - o As 14 votes were needed to be a ¾ majority, both proposals failed
 - The membership structure will remain as it currently is.
- Kaara encouraged any and all members that want to join the membership committee to please do so.
- A round of applause and a **BIG** thank you from all the members present was given to Denise Green for her Presidential term.
